# Screening

Bodyguard Tourism Services screens their Security Officers through PSIRA and SAPS before employing them into the company. This exercise enables the company to recruit or to employ security officers free from criminal activities as PSIRA and SAPS are the only professional bodies accordingly dealing with this aspect.

Attendance of the recognized Security Training with accredited Security Training Institutions is also scrutinized in detail.

# Site Supervisors

It is our policy to provide a service of Quality and Flexibility that will continuously meet the needs of our Clients. Site supervisors are fully trained, vetted, uniformed, and in possession off all the necessary competencies and qualifications.

BTS Site Supervisors visit all client premises randomly during on-duty Shifts to ensure that Guards are on post and fulfilling their duties professionally. Supervisors also ensure guards are appropriately dressed and outfitted with security Aids for their tasks.

The maintenance of round the clock supervision at irregular intervals is the sole responsibility of this division's activities to promote alertness. This is a 24 hour-line function responsibility from the top.

All security personnel on duty are expected to report hourly to the Central Control Office through their mobile devices supplied. They understand that they are the first impression to customers and act in a friendly and professional manner – trained to deal with many different conflict scenarios.
